Subject: Revision of fees payable by CIWG category by DASA

Dear Sh. Palaniswamy,

You would recall that the fee payable by the CIWG students for pursuing professional courses after admission under Direct Admission of Students Abroad (DASA) scheme, was enhanced from US\$1600 per annum to US\$8000 per annum last year. After receipt of representation from Indian community, the Mission had taken-up the matter with the MEA. In response, Hon'ble EAM had taken-up the matter with the Minister of Human Resource Development (MHRD) seeking reconsideration of their decision.

MHRD has now informed the Ministry that they have since reviewed the tuition fee for CIWG students, and decided that students belonging to CIWG category taking admission in undergraduate programmes of NITs under DASA scheme will pay a tuition fee of Rs.1,25,000/- (about US\$ 2,000) per student per annum either in Indian Rupees or equivalent US Dollars at existing exchange rate. A copy of MHRD's letter No.41-12/2017-TS.III dated 14 June 2017 addressed to Visvesvaraya National Institute of Technology (VNIT), Nagpur, which is in-charge of DASA admissions for 2017-18, is enclosed.

In your capacity as Coordinator of Principals Forum, you are requested to pass on the above information to all Indian Schools in Bahrain for further dissemination amongst the interested parents, who may benefit from the above decision of MHRD.


Sir,

I am directed to refer to this Ministry's communication F.No.35-10/2013-TS.III dated 8th March, 2017 (copy enclosed) vide which the CIWG reservation and its fee structure was communicated under para 2 (1) of the above referred communication.

2. The matter of tuition fee structure for the students belonging to Children of Indian Workers in the Gulf (CIWG) category has been reviewed in the Ministry. The competent authority has decided that the students belonging to CIWG category and taking admissions in the undergraduate programmes of the National Institutes of Technology (NITs) under the Direct Admission of Students Abroad (DASA) Scheme will pay tuition fee of Rs.1,25,000/- per student per annum either in Indian Rupees (INR) or equivalent US Dollars at existing exchange rate.

3. The DASA coordinating Institution is requested to implement the above mentioned decision for admissions to the academic year 2017 – 2018. The other contents of communication of even number dated 8th March, 2017 (copy enclosed) remain unchanged.
