## **ACCESS TO THE ONLINE CLASSES:**

We request you to make note of the following:

- Students who have been attending TEAMS Virtual Classes in the previous academic year, can log in to their TEAMS account from the Desktop App or Mobile App as usual.
  - ( Please ignore the Login steps mentioned below).

## <u>LOGIN STEPS FOR USERS SIGNING IN FOR THE FIRST TIME ( NEW ADMISSIONS)</u>

Kindly follow the following steps to sign in to your ward's Microsoft Licensed ID:-

- 1. Open the internet browser (Chrome) and type 'Office 365 Login'
- 2. Click **Office 365 Login**
- 3. Click Sign in
- 4. The student User ID is **GR No@indianschool.bh** 
  - a. For eg. If the GR No. is 37896, the ID will be 37896@indianschool.bh
- 5. The password will be **Virtual123**
- 6. Once the student signs in with the Email ID and password, the system will prompt to change the password.
- 7. Change the password (remember the ID and password).
  - \* Password must be eight or more characters long.
  - \* Password must contain characters from two of the following four categories:-
  - a. Uppercase characters A-Z (Latin Alphabet)
  - b. Lowercase characters a-z (Latin Alphabet)
  - c. Digits 0-9
  - d. Special characters (!, \$, # etc)
- 8. If prompted for mobile verification, please enter your mobile number, after clearing the details in the text box and follow the instructions.
- 9. If on a Laptop/PC, your ward will see many Icons including Outlook and Teams on the page.
  - Your ward will be ready to join Microsoft Teams online classes upon invitation by the teachers. All scheduled meeting notifications will appear in Teams Calendar as well as Outlook.
- 10. If on mobile, kindly download Teams App and use the same ID and password to log in. Your ward will be ready to join Microsoft Teams online classes upon invitation by the teachers.
- 11. Once all students set their accounts the school will update the schedule and procedures for the online classes.
- 12. Please note that each child will have to log in separately using their GR. No.
